FOSTER'S AGREEMENT

1. I understand that I am providing a temporary home for my foster pet until Eva's Kitties, Inc. is able to find the cat an approved permanent home.
2. I understand that Eva's Kitties, Inc. makes all final decisions regarding the approval of potential adopters and the adoption of foster pets, although the foster parent does have input into the decision.
3. I agree that the animal being fostered must remain in my possession and will not be sold, adopted, or given to another party.
4. I agree that I will not declaw the cat or allow the cat outdoors.
5. I agree to care for the animal in a humane manner and be a responsible animal guardian. This includes supplying adequate food, water, shelter, and attention/socialization.
6. Eva's Kitties, Inc. will cover all medical costs while you are caring for the cat(s), including medications if necessary and any trips to the vet. I understand all treatments to the cat(s) I am fostering are to be discussed in advance with one of the Foster Coordinators. If requested in advance, the organization will also pay for the food and litter.
7. I agree that if at any point I cannot keep the animal, I will return him/her to Eva's Kitties, Inc. after first discussing the transfer with one of the Foster Coordinators.
8. I agree that accidental animal bites or other injuries to humans and other animals do occur, and agree to hold harmless, and indemnify and protect Eva's Kitties, Inc. from any claim or suit filed by anyone as a result of such an incident.
9. I understand and agree that Eva's Kitties, Inc. is not responsible for any illnesses or injuries the animal might give to my own personal pets.
10. I give Eva's Kitties, Inc. permission to call my home at any reasonable time to assure that the animal is being cared for and treated properly.

11. I agree to provide periodic updates about the foster cat's health and behavior.
12. I agree to notify Eva's Kitties, Inc. as to any behavioral or health problems of the animal. Eva's Kitties, Inc. reserves the right to determine the proper course of action to take upon such notification.
13. I agree to inform Eva's Kitties, Inc. if I plan to be away for any length of time.
14. I agree to keep Eva's Kitties, Inc. informed of my current home address, phone number, and email address.
15. I have received, read, and understand Eva's Kitties, Inc. *Foster Home Guidelines*.
16. I agree that the cat that I am fostering belongs to Eva's Kitties, Inc. and I will surrender it to Eva's Kitties, Inc. upon request.

This is a legally binding contract.

I agree that all statements I have made on this form are true. If it is found that any statements I have made on this form are not true, the fostered animal will be confiscated.
